The board (“**Board**”) of directors (“**Directors**”) of SIM Technology Group Limited (“**Company**”, together with its subsidiaries, “**Group**”) hereby announces that the unaudited monthly revenue of the Group was as follows:

1. Comparison of revenue with last month

Both the Group’s deliveries and revenue from core business in November 2023 were roughly the same as those in October 2023. The revenue from non-core business predominantly comprised of rental income. The revenue from non-core business in November 2023 was roughly the same as that in October 2023.

2. Comparison of revenue from core business with same month last year

Due to the adjustments by the Group's customers in respect of the delivery time of their purchase orders, the Group's deliveries and revenue from core business in November 2023 both decreased significantly as compared to those in the same period last year.

3. Comparison of total unaudited revenue of the Group for the eleven months ended 30 November 2023 with same period last year

Due to the adjustments by the Group's customers in respect of the delivery time of their purchase orders, the total unaudited revenue of the Group for the eleven months ended 30 November 2023 decreased as compared with that in the same period last year.

The core business of the Group comprises the ODM (original design manufacturer) of handsets and IOT terminals business and the non-core business of the Group comprises properties management.
